# HALL COMMISSIONERS/HALL TAX ASSESSORS ALLOW CHIEF APPRAISER HENDERSON TO WORK UNDER INVALID CONTRACT FOR OVER THREE YEARS!!!

HCCFEG filed an open records request on 10-16-2009 requesting the Hall County Commissioners to provide a copy of the minutes or other documentation to verify they had officially approved the employment contract/ agreement that Chief Appraiser Henderson has been working under since 12-21-2006. OCGA 48-5-298(a) requires the Hall County Commissioners to approve any employment or contract agreement offered by the tax assessors. The fact is the Hall County Commission has allowed this individual to work illegally for over three years! The response to our request was received by e mail on 10-20-2009. This e mail stated *THERE WERE NO DOCUMENTS RESPONSIVE* to our request for documentation to verify the Hall County Commissioners had ever approved the Chief Appraiser contract/employment agreement!

Evidently the Commissioners had this issue on their minds as well in that HCCFEG discovered ,through an open records request, a letter dated 10-12-2009 that was sent to the Hall County Tax Assessors from the Hall County Commissioners asking that a copy of the contract/employment agreement that Chief Appraiser Henderson was working under be sent to them. This letter further stated their request was made in accordance with OCGA 48-5-298(a) which *REQUIRES THE COMMISSION TO APPROVE* any employment contract or agreement offered by the Hall County Board of Tax Assessors. This letter was signed by four commissioners. Commissioner Billy Powell did not sign the letter and stated he was opposed to the letter. Why would Billy Powell be opposed to following the law as outlined in 48-5-298(a)? Did the assessors send this information to the Commissioners as requested? If the information was sent to the Commissioners as requested, what actions have the Commissioners taken to remedy this law violation over the last five months?

HCCFEG reviewed this matter once again on February 11,2010 and was advised by Hall County that Mr. Henderson was still working under the original contract/employment agreement and it has not been approved by the Commission and remains in violation of OCGA 48-5-298(a).

Why do the Hall County Commissioners continue to drag their feet on this matter? What power does Chief Appraiser Henderson hold over the tax assessors? What power do the tax assessors hold over the Hall County Commissioners? Tax payers should begin asking questions about this matter during this election year and see if we have at least one Commissioner that will have the courage to come forward with an explanation as to why they are knowingly disregarding the law!
